The first Annual Kick Butts Day events for the ABC Unified School District were held on 4 high schools on Tuesday 3/19/12 ad Wednesday 3/20/12, with the entire student body viewing the activities. Activities included: pledge walls, tobacco quiz show, dance performances, and information displays/tables. More than 840 students signed the pledge wall. A portion of the student body actively participated in other activities, including:

Gahr high School 3/19/12 80 youth participating, including 12 on stage Tracy High School 3/20/12 100 youth participating, including 20+ on stage Artesia HIgh School 3/20/12 90 youth participating, including 25+ on stage Cerritos High School 3/20/12 100+ youth participating, including 20 on stage

Comments regarding question 14:

41 youth participated in a youth-adult mentorship training on Oct 28, 2011, which included the following topics: body image and self-esteem; tobacco, drug, alcohol media messages directed at youth; cyber bullying issues, and conflict resolution skills.

50 youth from 5 high schools participated in a youth development training on February, 2012, to organize Kick Butts Day at their respective school. The training was organized collaboratively by partners Asian American Drug Abuse Program and Los Angeles County Office of Education/Friday Night Live. At the training, youth learned how to do large-scale activities, such as pledge walls, and information about tobacco ingredients. Calendar and planning timeline from workshop also worked well to prepare multiple groups for KBD event planning. Students volunteered to be the lead primary contact for their school, and this seemed to have provided adequate resources and support. Only

Class lessons on dangers of second-hand smoke (as a contributor to Sudden Infant Death Syndrome) were given to our students enrolled in parenting classes.
