Comments regarding questions 7, 8 & 9: No sting operations were performed this year due to budget concerns with Riverside County Department of Environmental Health. Students participated in creating, directing and filming Public Service Announcements regarding living tobacco-free
lifestyles and information about vapes to educate peers, as well as a Public Service Announcement for World No Smoking Day (World No Tobacco Day). Students participated in Anti-tobacco Advocacy and Service-Learning projects including the Coasta Clean Up, local park clean ups, the Red Ribbon Celebration activities at individual school campuses, the Family Fun Festival, activities for Through With Chew Week, the Great American Smoke Out, managing tobacco education booths at Hero's Vs. Villains, Corona Fundamental Intermediate School, Ramirez Intermediate, Norco Intermediate, Santiago and Centennial high
Comments regarding questions 11 & 12: 43 students were identified for Saturday School, however 12 students failed to attend due to circumstances beyond our control such as transferring to another school outside of the Corona-Norco Unified School District.

Seventeen students were identified and participated in the TAP program on six out of eight high school campuses. 11711 students were also referred to the California Smoker's Helpline through the TAP, TEG and Brief Intervention program; as well as to all students during lunch-time activities at Corona-Fundamental Intermediate School, Norco Intermediate, Ramirez Intermediate, Santiago High, Centennial High and Norco High School.

6th grade students were taught Project TNT; 7th and 8th grade -Project Alert. High School students - TND. 6th-12th grade students participated in non-curricula activities through Friday Night Live and American Cancer Society Youth Clubs, and the UNITY Youth Advisory Council. They also served as Peer Educators. 7th and 8th grade students participated in intervention programs - Brief Intervention or TEG. High School students - TEG. Cessation groups were conducted at High Schools.
