Comments regarding questions 9-12:

The Great American Smoke Out was implemented by 3,867 students from Corona Fundamental Intermediate School, Citrus Hills, Norco High and River Heights Club Live and Santiago High School American Cancer Society (ACS). Students participated in anti-tobacco activities at their school sites, such as Stomp Tobacco Out using balloons, peer education and anti-tobacco messages. The Red Ribbon Week Celebration was implemented district-wide with 54,000 students participating in activities at individual school sites such as tobacco and drug-free pledges, anti-tobacco and drug grams and messages, Public Service Announcements and school and classroom decorating contests. Students participated in the district-wide Poster, Creative Writing and Media Contest and attended the Red Ribbon Family Fun Festival. Kick Butts Day was celebrated by 4,674 students from Adams Elementary, Citrus Hills Intermediate and Santiago High School American Cancer Society in activities such as pledges and peer education. The 15th Annual Youth Quest was implemented at Citrus Hills Intermediate, Corona Fundamental Intermediate School and River Heights Intermediate School. Approximately 153 students participated in tobacco education and prevention activities such as peer education, team building and leadership development. Johnnie Williams of Riverside County Friday Night Live attended River Heights Intermediate Club Live as an assembly speaker on the topic "What It Means to Stay Above the Influence" of tobacco, alcohol and drugs. She also conducted skill building activities for leadership and public speaking. Christopher Latham of the Boys and Girls Club of Fresno County Tobacco Decoy Program spoke to students at Corona High Friday Night Live about tobacco education and prevention and how the decoy program works.

Comments regarding questions 14-15:

Youth involvement in the STAKE Act includes one student from Corona who volunteered to work with the decoy program. A total of 41 other law enforcement decoy sting operations involved local students and took place in Corona and Norco. Youth involved in anti-tobacco advocacy projects include students from six Club Live and American Cancer Society clubs and the United Neighbors Involving Today's Youth: Youth Advisory Council. Projects include the Great American Smoke Out, Kick Butt's Day, Youth Quest, cigarette butt clean ups at local parks in Corona, Norco, Eastvale and surrounding neighborhoods. Students also made anti-tobacco pledges, sold anti-tobacco and tobacco education grams to other students, researched and shared tobacco education videos regarding cigarettes, vapes and chewing tobacco and made rap songs with anti-tobacco messages. Youth were involved in a variety of Media Literacy and Youth Media Production to county the influence of the tobacco industry including Public Service Announcements featured school wide at Ramirez Intermediate School and Citrus Hills Intermediate School. Students from John F. Kennedy (JFK) Middle College volunteered to participate in a cross-age tobacco peer education program to elementary school students. Students participated in a two-day training and created their presentations to include

Students from Norco High School, a priority population for U CAN STOP, also participated in multiple youth development activities throughout the year.
