Five Whitcombe students attend the Youth Quest 2011 in Sacramento this year. They met with anti-tobacco lobbyists and legislative representatives to discuss ways in which youth can get involved in the tobacco free movement.
Comments regarding question 8:
THOUGH WE ARE A TIER 1 GRANT RECIPIENT, WE STILL USED AN INTERVENTION CURRICULUM WITH OUR TOBACCO POLICY OFFENDERS. The guidance counselor at Whitcomb uses the TEG curriculum with students who violated the no tobacco policy on campus. She had three students this year that she met with weekly.

Whitcomb is a continuation high school in which every child is at risk in some way.

We have one cessation counselor, one guidance counselor and four teachers who deliver the prevention, intervention or cessation curriculum.

Comments regarding question 13:

Presents received three mailings with TUPE information.

Comments regarding question 14:

All prevention and intervention lessons were administered by school staff members, whereas the cessation curriculum was administered by a drug/alcohol counselor. The Los Angeles County Dept. of Health worked with us on our Youth Quest project and "Kick Butts" campaign. The district continues to conduct quarterly meetings for the Coordinated School Health Advisory Committee in which members of the community and schools collaborate on district wide health programs.
