163 middle and high school students participated in Mariposa, a young women's empowerment program that utilizes Young Women's Lives curriculum along with other resources. Of the 163 participants, 9 high school students were trained to lead Mariposa groups with 84 high school participants and 70 middle school participants. In response to a need in certain schools, we piloted a young men's violence prevention program that utilizes Young Men's Work curriculum as a complement to Mariposa. In this pilot, 46 young men participated, including 23 non-traditional high school students and 23 middle school students. 10 students attended the Teens Tackle Tobacco conference. They

These had the potential of reaching 1,403 students. Teen Dating Violence Events conducted by Mariposa participants – 718 students Alcohol Awareness Month Town Hall Meetings (which included information about tobacco and e-cigarettes) – 240 students Additionally, Ralph Cantor spoke with 40 parents about marijuana and e-cigarettes.

This year we brought the Smoking Intervention into the classrooms of identified smokers. Our non-traditional schools have the highest smoking rates in the county, so we focused on those classrooms this year. Our instructor provided the Smoking Intervention (a combination of Brief Intervention and Craving Identification and Management) to 5 classes and reached 157 students. Teachers and students were both satisfied with the classes and expressed interest in having them next year. Additionally, the classes helped us identify students who are interested in quitting. We will be providing a cessation class at the schools in the coming year for those students.
